Arrival/Departure Information

Eagle Lake is roughly one hour from the Colorado Springs Airport. We do not provide transportation from Denver International Airport nor local pick-ups from Colorado Springs residents.

Eagle Lake will not be held responsible for transporting campers whose transportation form is not returned 14 days prior to their week of camp. If it is impossible for you to make transportation plans 14 days prior to camp, please call the office at 719-472-1260. All campers must have a set airline arrival and departure time in order to be included on a transportation run. Because of tightly scheduled arrangements, we cannot pick up campers flying stand-by.

****Note:** Equestrian Programs normally have a Friday morning horse show. Every effort is made to ensure that these campers are able to participate in the show. Please try to schedule flights for Equestrian campers between 2pm and 4pm (this does not guarantee that they will be able to make the show but certainly improves their chances, depending on the transportation available.)

Unaccompanied Minor

If coming by plane, please check with your airline about their unaccompanied minor policy. Many airlines charge an unaccompanied minor fee each way. Be sure to make prior arrangements, as Eagle Lake will not pay this fee.
